

RELEASE OF LIABILITY and PERMISSION TO USE

Hasbro Nerf® Dart Tag Events – 2009 Tour

PLEASE READ CAREFULLY BEFORE SIGNING. THIS IS A RELEASE OF LIABILITY, INDEMNITY, CONSENT TO USE PHOTOGRAPHS/VIDEO, AND WAIVER OF CERTAIN LEGAL RIGHTS.

I, the undersigned participant and the participant’s parent/legal guardian if participant is under 18 years old (collectively “I”), understand and acknowledge that participation in the *Nerf Dart Tag* activities advertised, organized, promoted and/or sponsored by Hasbro Inc. (“Hasbro”) at the NERF DART TAG DEW TOUR NERF Dart Tag World Championship , including but not limited to playing games of *Nerf Dart Tag* within a tent and/or inflatable maze or otherwise on the premises (collectively referred to as “the events”), involve inherent risks to both person and property. I acknowledge that the risks include but are not limited to personal injury, loss, damage, or death, caused by factors such as terrain, facilities (including the inflatable maze and/or tent), temperature, lack of hydration, weather, equipment, *Nerf* products, vehicular traffic, my own actions, and actions of other people. With full recognition of the risks, I voluntarily agree to assume all of the risks of my (my child’s) participation in the events, including but not limited to playing one or more games of *Nerf Dart Tag*. I further represent and agree that I (and my child) have no medical or physical condition that would endanger me (my child) as a result of participation in the events, and further represent and agree that I (and my child) are not under the influence of drugs or alcohol at the time of signing this Release or at the time of my (my child’s) participation in the events. In consideration for being allowed to participate in the events, I further agree to release, indemnify and hold harmless Hasbro and its employees, agents, representatives, officers, directors and insurance carriers, Vivid Marketing, and the Alliance of Action Sports (Alli), LLC, NBC Universal, Inc., NBC Sports Ventures, Inc., MTV Networks, a division of Viacom International Inc., and its affiliates, Murphy Productions, Inc., Winning Medicine International, Inc., their Chicago Park District, and members of the Chicago Park District Board of Commissioners, the City of Chicago, Delaware North Companies, Inc. – Boston, Comcast Spectator, L.P., Global Spectrum, L.P., Portland Arena Management, LLC, the City of Portland, the State of Oregon, Larry H. Miller Arena Corporation, the Salt Lake City Corporation, Orange County, the city of Orlando, their respective representatives, members, officers and employees, and those in privity with them including without limitation any co-promoters, sport organizers, track designers/builders, participants, sanctioning organizations or any subdivision thereof (collectively the “Releasees”), from any and all liability and claims for injury, death or property damage arising from participation in the events. I expressly intend this Release to include a release of liability for any injury, death or other damage to me or my child caused by the ordinary negligence of Hasbro or the other Releasees.

NERF Dart Tag League (NDTL) World Championship Details: I, the minor’s parent/legal guardian, acknowledge that I have been provided a copy of the NDTL Official Rules of Play and certify that I fully understand these rules of game play. Furthermore, I attest that as part of the Official Tournament Rules of Play, I have reviewed and fully comprehend the details of the NDTL Tournament, including but not limited to the Tournament entry process, Tournament structure and format, Tournament bracket size, elimination procedures, Tournament contest structure and grand prize details. I, the minor’s parent/legal guardian represent that all NDTL tournament participant information I have provided is correct and truthful, including contact information and participant age at the time of registration. In addition, I accept that as part of the NDTL Tournament contest rules, all personal information may be verified independently by Hasbro or its agency representatives.

I hereby give Hasbro and its agents, assigns, licensees, and legal representatives the irrevocable right to use and reproduce my (my child’s) name (or any fictional name), picture, portrait, image, photograph, video and movie footage taken of me (my child) while participating in the events, in any and all forms of media and media devices, including but not limited to print, television, and Hasbro’s Internet website addresses, and in all manners, including composite or distorted representations, for advertising, promotional or any other lawful purposes, and I waive any right to inspect or approve the finished version(s), including written copy that may be created in connection therewith. I understand that I am to receive no monetary compensation for the grant of these rights.

I agree that this Release and any/all claims arising from the Release or participation in the events shall be governed by Rhode Island law and that exclusive jurisdiction of any claim shall be in Rhode Island courts.

This Release shall be binding to the fullest extent permitted by law. If any part of this Release is deemed to be unenforceable, the remaining terms shall be an enforceable contract between the parties. This Release shall be binding upon the assignees, subrogors, heirs, next of kin, executors and personal representatives of the undersigned.

Parent/Legal Guardian: By signing this Release, I, the minor’s parent/legal guardian, represent and declare that I am the legal parent or guardian of the minor with full legal capacity and authority to act for and on behalf of the minor, and that I am granting permission for the minor to participate in the events, including playing games of *Nerf Dart Tag*. I acknowledge and understand that by signing this Release on behalf of a minor, the minor shall be bound by all the terms of this Release, and that I am waiving certain rights on behalf of the minor that the minor otherwise may have. I agree to indemnify and hold Hasbro and the other Releasees harmless for any claims or liabilities assessed against them as a result of any insufficiency of my legal capacity or authority to act for and on behalf of the minor in the execution of this Release. **I HAVE CAREFULLY READ THE FOREGOING RELEASE, UNDERSTAND ITS CONTENTS, AND AM AWARE THAT I AM RELEASING CERTAIN LEGAL RIGHTS THAT I OTHERWISE MAY HAVE.**
